Who we are

JAG Jewelry – Jewelry Andreas Gmur SA, Switzerland

We are the company Jewelry Andreas Gmur SA which creates, designs, produces and markets jewelry, gems and pieces of fine jewelry under the brand name JAG Jewelry. We own the website www.jag.jewelry and all of its sub-domains identifiable by the ".jag. jewelry/" form.

What data do we collect when you use our websites

- Firstname (only when you send us a message)
- Name (idem)
- Phone number (idem)
- E-mail address (idem)
- IP address from which you visit the site
- Technical information about your Internet browser and the hardware on which it is installed

Methods and purposes of collecting personal data

The personal information we collect is collected through forms and through the interactivity established between you and our website. Your personal information is collected through contact forms. The information collected is used to process your requests for information, to establish a contact card in our management system, and to manage the website (presentation, organization).

Once you are a customer or wish to do a project with us, the information is collected by staff on the basis of a private contact at the shop/workshop or through any means of individual communications (phone, email, WhatApp, Zoom and similar communication applications) that will be used for dialogue, contact and project monitoring. The staff of JAG Jewelry, exclusively them, are therefore also aware of all the items collected.

Use of personal data collected

Comments, contact forms

When you leave a comment on our website, or our social networks or use the contact form, the data listed in the form, but also your IP address and your browser user agent are collected to help us detect unwanted comments or spam.

Cookies

This site uses cookies — small text files that are placed on your machine to help the site provide a better user experience. Cookies are used to store user preferences, store information to provide anonymized tracking data to third-party applications such as Google Analytics. As a general rule, cookies will make your browsing experience better.

On-board content from other sites

How long do we store your data.

Transmission of your personal data

How do we protect your data

JAG Jewelry makes sure to protect and secure as much as possible, the personal data you have chosen or are required to share with us, as well as all the data we have in connection with your experiences with JAG Jewelry.

Conditions for processing and storing personal data

Place where your personal data is stored
